



## UMM AL EMARAT PARK FILMING & PHOTOGRAPHY RULES & REGULATIONS

Event organizers who wish to request videography and photography are kindly asked to adhere with the below guidelines:

- The commercial photography and videography permit must be presented to security at the Park before entering the premises
- All visitors must purchase an entry ticket
- Only venues mentioned in the permit will be deemed appropriate for the shoot
- Videography or photography is not permitted at the main entrance of the Park
- Only the equipment mentioned in the permit will be allowed on the premises of the Park
- Photography and videography organizers must abide by health and safety rules and regulations
- Food from outside the Park is not permitted (only in the maintenance building) Public displays of affection are not permitted
- Music, singing and dancing is not permitted
- Photography and videography of Park visitors is not permitted
- Photography and videography on the premises of F&B outlets requires the approval of both the Park and F&B management
- Display of any content on public platforms is not allowed (unless with written approval)
- Photography and videography organizers are not permitted to display any marketing materials on site
- Security reserves the right to stop the shoot at any time they deem appropriate
- All visitors must adhere to the park's dress code, in line with UAE laws and regulations
- General rules and regulations of the Park are applicable
